WE ALSO FUND GRANTS TO MCPL WHICH SUPPORT A VARIETY OF INITIATIVES INCLUDING: EARLY LITERACY CENTERS, COMPUTER STATIONS, AND DISCOVERY ROOMS FOR CHILDREN; GO! KITS - TAKE-HOME TECHNOLOGY PACKS WHICH INCLUDE BOOKS, SCIENCE KITS, AND IPADS PRE-LOADED WITH EDUCATIONAL APPS; STEM STATIONS AND VARIOUS OTHER PILOTED TECHNOLOGIES AND SOFTWARE.
